Dear Parents and Students,

First, we would like to welcome you to “OVATIONS” re-opening on **Monday, September 10th, 2018**. We have a lot of new activities planned for the students. We are pleased to put all of this together to enhance your child’s dance education and make this an exciting new year!

Following are the rules and regulations for the school. Please read them carefully, fill out the last two pages, sign it and return it to Ovations before your child’s first class of the new year. For insurance purposes, no child will be permitted to start dance class until all forms are complete

Trial Classes

Ovations offers **1 trail class in the month.** Students that take more than 1 within the month will be responsible for payment.

Parking on OVATIONS Property Only

Please DO NOT park in front of the Post Office or Lin Care. They receive night deliveries and cannot back their trucks to the door. Please note: **THEY WILL TOW YOUR CAR!**

Teachers and Assistants

Our school is professionally staffed. All of our teachers and their assistants have significant professional experience to well qualify them to provide the best training to all of our students. Occasionally, our teachers will rotate classes. This serves several purposes. It provides input from different instructors on your child’s technical training and acquaints each student with other teachers in case they are needed to substitute. The Director is always available for questions or concerns. **(Leave your name and phone number at the front desk, and you will be contacted.)**

Payments

Please note, Ovations has hired a Business Manager to take care of **all** payments and financial arrangements. Ovations has left trust in the business manager, so any and all arrangements made by you and the manager are final. Be sure to read your payment contract thoroughly.

A class with 5 or less students will be dropped and those students will be moved to a class at the same level, as will classes with more than 18 students per class.

There is also \$25.00 **non-refundable** registration fee per year per student.

Second and third sibling fee is \$23.00.

Information Letters

All future school information-letters will be emailed or you can be pick one up next to the competition box on the wall across from the office. Letters **will not be given** to the students.

This is the parents responsibility! The students lose or forget them!

Reminders

Please remind your children not to leave their purses, cell phones, etc lying around. Small children may think they are toys and play with them.

Ovations was created to enhance your child’s self-esteem and sportsmanship, as well as give them a family atmosphere while receiving the best training possible. Positive reinforcement at home helps these students feel good about themselves. We look forward to another great year!

Annual Show May 18th, 2019

Each year we present our annual student performance. Ovation will have both a matinee and evening show. Due to the amount of dances in our show, Ovation will divide the dance numbers between shows, with the possible chance of having a separate pre-school show, to keep the performances at a reasonable time length. We would like all students to participate if they wish; however, our annual show is optional. Those choosing to participate are asked to purchase one costume per class, tights and tickets to the show. A professional photographer will be offering packages for pictures, a florist will have flowers on sale, and a show video/DVD will be available for purchase. This is done for your convenience and is optional to you. Additional details of our productions will be given at a later date.

Costume Payments

All costumes are chosen Thanksgiving weekend and costume orders are sent out December 31st to insure delivery by April. **No refunds will be made after our order is placed in December.** **Costumes paid for and not picked up by June will be donated with no refund.** This is not our personal policy, rather that of the costume distributor. To be fair and consistent, costumes are picked from the price range shown below:

Small-Medium Child: \$86.00 per costume

Large Child: \$86.00

X-Large Child: \$88.00

Small-Medium-Large-X-Large Adult: \$90.00

XXL \$90.00

Studio Costumes

Studio costumes are paid for in **TWO** payments - The months of October 1st and November 1st.

This does not include tights, which are purchased in February. (Cost see above). When ordering costumes from a costume company they must be paid in full in advance. Our orders must be placed by December 31st, in order to guarantee arrival by April. Ovation does not have the funds to pay for student costumes. Please be sure to check your budget before committing to costumes you may not be able to afford.

Costume checks are to be paid individually to APPLAUSE! (Please do not apply to tuition checks!) A \$15.00 late fee per costume will be charged to your account if not paid by the due date.

Payment Policy

Yearly Tuition Program - Ovations tuition is based on our school year of **31 weeks** then divided into 9 installments.

Each month has **3-4 or sometimes 5 weeks** Ovations divides tuition into equal monthly payments to make tuition more convenient.

****Please remember Ovations is not a monthly tuition school, but a yearly tuition academy.**

Holidays

Holidays posted on Ovations school calendar are already subtracted from your yearly tuition. Calendars will be available in September at the front desk.

Snow Days/Unexpected Closings - Please call Ovations answering machine after 1:00pm for any unexpected closings.

*We offer make-up classes for vacations, sickness and school functions.

Failure to abide by school policy will result in your children's removal from class.
